### MINUTES WAYCROSS CITY COMMISSION MEETING TUESDAY, JANUARY 19, 2021 5:00 PM

The City of Waycross Regular City Commission Meeting was held on Tuesday, January 19, 2021 in the Commission Chambers of City Hall. The meeting was called to order at 5:00 p.m. by the Mayor Michael-Angelo James. Members in attendance were: Mayor Michael-Angelo James, Mayor Pro Tem Henry Strickland, Commissioners Norman Davis, John Threat, Diane Hopkins, and Marian Solomon-Gaines. Commissioner Norman Davis was absent.

Mayor Michael-Angelo James introduced Chief Eddins, Waycross Fire Department, who offered the opening invocation. The Invocation was followed by the Pledge of Allegiance led by Mayor Michael-Angelo James.

A Public Hearing for Text Amendment Request for Article VI – General Provisions to add Section 619 was scheduled for February 16, 2021 at 4:30 p.m. was set by Attorney Rick Currie.

Mayor Michael-Angelo James announced the vaccine for COVID is available. The schedule is now in Phase B.

There were no public remarks on official action.

Mayor Michael-Angelo James presented the Consent Calendar as read by Acting City Clerk China Williams Agu for consideration of official action as follows:

Approval of Minutes: Planning and Information Session and Executive Session, Monday, January 4, 2021, 5:00 p.m.; Public Hearing, Tuesday, January 5, 2021, 4:45 p.m.; Waycross City Commission Meeting and Executive Session, Tuesday, January 5, 2021, 5:00 p.m.

No Ordinance was presented for second reading:

There were no Consent Resolutions or Privilege License Renewals.

The Consent Calendar was approved by motion from Commissioner Diane Hopkins, seconded by Mayor Pro Tem Henry Strickland, all voted in favor and the motion carried.

Finance Director China Williams Agu presented Bid # FY21-12 Alpha/Ethel Street. The City of Waycross has recently approved the sell of 0.204-acre lot on Alpha/Ethel Street. Purchasing received 1 bid on this 0.204-acre lot. Bids were sent out to 3 neighboring or adjoining property owners. Staff recommends to accept the bid of \$800.00 from Tyrone S. Harris, Sr.; the lot adjoins his property. Commissioner Marian Solomon-Gaines made the motion to approve the bid FY21-12 Alpha/Ethel Street. Commissioner Diane Hopkins seconded the motion. All Commissioners voted yes, and the motion passed.

Purchasing Director Linda Jones presented Bid # FY21-10 Water Tank Inspections and Washouts. The City Commission requested formal bids be issued for Annual Water Tank Inspections and Washouts. Purchasing received two bids and staff recommends awarding the bid

to American Tank Maintenance for an annual cost of \$14,681.00 for a period of five years for a total of \$73,405.00. Commissioner Marian Solomon-Gaines made the motion to approve the bid for Water Tank Inspections and Washouts. The bid was seconded by Mayor Pro Tem Henry Strickland. Discussion was made; all voted in favor, and the motion passed.

Finance Director China Williams Agu presented Surplus Property WAYX 21-05. Ms. Agu presented a list of items no longer needed in any City department and is requesting that these items be declared surplus property. The vehicle be traded to Enterprise Fleet Management; bar screens will be sold as scrap on GovDeals.com. Commissioner John Threat made the motion to sell surplus items on GovDeals.com and traded to Enterprise Fleet Management. The motion was seconded by Mayor Pro Tem Henry Strickland; all voted positively and the motion carried.

Finance Director China Williams Agu presented Bid FY21-14 Banking Services. The City of Waycross issued a request for Banking Services. 7 Bids were sent out to local banking industries. Two bids were received. After reviewing two bids, staff recommends awarding the bid to Ameris Bank as being the lowest monthly cost and best interest rates. Interest rates will offset the cost of monthly fees. Commissioner John Threat made the motion to approve Ameris Bank of Waycross, Georgia as the new banking service provider. Commissioner Solomon-Gaines seconded the motion. Discussion was made. The motion was approved with a 4-0 vote.

#### **RESOLUTION NO. R21-02**

### A RESOLUTION OF THE CITY OF WAYCROSS, GEORGIA, TO ESTABLISH QUALIFYING FEES FOR CITY OF WAYCROSS ELECTIONS FOR 2021; AND FOR OTHER PURPOSES.

WHEREAS, O.C.G.A. Section 21-2-131 requires the governing authority of each municipality, not later than February 1 of any year in which a general primary or general election is to be held, to fix and publish a qualifying fee for candidates for compensated municipal office; and

WHEREAS, O.C.G.A. Section 21-2-131 also authorizes the governing authority of a municipality to fix and publish a qualifying fee not to exceed three percent (3%) of the total gross salary of the office paid in the preceding calendar year; and

WHEREAS, Section 13 of the Charter of the City of Waycross sets the salary of a city commissioner in an amount not to exceed \$6000.00 per annum; and

WHEREAS, said matter having been considered.

**NOW THEREFORE, BE IT RESOLVED** by the Commission of the City of Waycross that the qualifying fee for candidates for the office of Commissioner of the City of Waycross for the election to be held in the year 2021 shall be three percent (3%) of the annual compensation of the prospective office and is hereby set at \$180.00.

**BE IT FUTHER RESOLVED** that the City Clerk shall publish the amount of the qualifying fee for the office of Commissioner of the City of Waycross.

WHEREAS, there is situated in Phoenix Park in Waycross, Georgia, a monument to Confederate soldiers who died during the Civil War and was placed there in 1910 by the Francis S. Bartow Chapter of the United Daughters of the Confederacy; and

WHEREAS, there is also a Civil War era cannon that was given to the Francis S. Bartow Chapter of the United Daughters of the Confederacy who thereafter placed it in Phoenix Park in 1910; and

WHEREAS, said above-described monument and cannon are not owned by the City but are privately owned since they were presented to the Sons of Confederate Veterans; and

WHEREAS, said matter having been considered.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that Richard E. Currie, City Attorney for the City of Waycross, is directed to pursue any and all legal means to remove the privately-owned Confederate monument and Civil War era cannon from Phoenix Park by any legal means, including but not limited to, the sending of a letter to the owner or owners of said monument and cannon to remove said monument and cannon from municipal property, and the filing of a lawsuit or civil action, if necessary.

**BE IT FURTHER RESOLVED** that the Mayor, City Manager, City Clerk and City Attorney be authorized, empowered and directed, on behalf of the City Commission, to do all the acts and things necessary in order to carry out the purposes of this Resolution, hereby ratifying and confirming all actions taken and to be taken.
