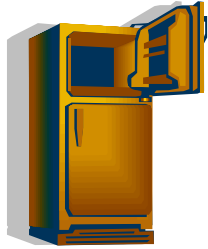


## Free five (5) Household items Collections



This refers to the weekly removal of large bulky items such as appliances, mattresses, furniture, carpet and other household items. Customers must call **287-2955** by 12:00 PM on Thursday to

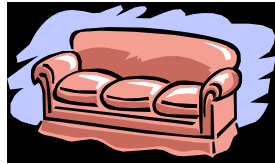
schedule a pick up of 5 items or less.

Collections begin at **6 AM** Thursday & Friday.

## To Schedule a Bulk Collection



If you have more than five (5) items, you may call the Public Works Dept. and request a special pick up. **\$36.23 –1/4 load, \$77.63 - 1/2 load & \$155.25 for a full load** must be paid in advance at City Hall. You will then be issued a pickup date on Tuesday or Friday.

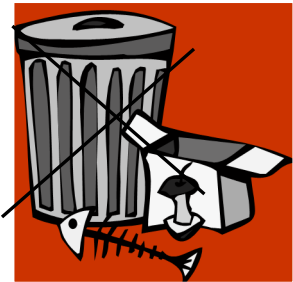
## Container



The city will issue you a container once a utility account is opened. Upon closing the account the Ryland Environmental will pick up the container, if it is not returned a fee of \$75.00 will be charged to your utility account.

## Other Containers

Only City issued roll-out container should be used for disposal of household garbage. All garbage should be placed inside the container. If one container is not sufficient, the City will provide an additional container with a 3 month minimum, for an additional fee.



## Damage

If your container breaks through normal use, the City will replace it at no cost. Please call the Utility Billing Department at 287-2941 to report a damaged container. If, however, it can be shown that the container was damaged through deliberate misuse, you will be charged for the container.

## Handicap Customers

Handicap customers with a City authorized medical form, signed by your physician, may have your garbage container emptied. Call Utility Billing at 287-2941 to request a medical form.



## Stolen Container



Report stolen containers to the Waycross Police Department at once. Upon receipt of a case number, contact Utility Billing at 287-2941 to have another can delivered.

## Placing the Container for Collection

The container must be placed curbside for collection no later than 6:00 am on your scheduled collection day, and no earlier than 6:00 pm the evening prior.

Do not place the container within five feet of any immovable object such as mailboxes, utility poles, fences or fire hydrants, etc. If a vehicle is blocking the container it **WILL NOT** be picked up.



## Removing Container After Collection

The emptied container should be removed from the right of way no later than 6:00 pm the day following your collection or a citation will be issued and a \$5.00 charge added to your utility bill, per **City Ordinance 13-3.**



## Holiday Collection Schedule



The only holidays your garbage collection will be affected are Thanksgiving, Christmas and New Year's Day. When these holidays fall on a collection day, your garbage pickup will be delayed one day later following the holiday.

## Yard Trash

Yard trash is defined as grass clippings, shrubbery cuttings, leaves and straw. Small limbs must not be longer than 4 feet in length and 6 inches in diameter. **Tree removal will not be picked up; this includes limbs, trunks, stumps and stump grindings.**



## Yard Trash Collection

Yard trash must be placed on the street right of way by **7:00 am** on your collection day, and must be within reach from the street. No collection will be made if yard trash is against a utility pole, fire hydrant, water meter, or on private property. Do not place yard trash behind or beside parked cars. **DO NOT mix litter with the yard trash, or no collection will be made.**

## Litter Control

DO NOT blow or place any debris into the street. Debris washes into the drains, causing a blockage. Any one caught putting debris in the street will be fined. **City Ordinance 33-3.**
