

# MINUTES WAYCROSS CITY COMMISSION CALLED MEETING

THURSDAY, JUNE 30, 2022 4:00 P.M.

## I. CALL TO ORDER:

The Called Meeting of Commission of the City of Waycross was held on Thursday June 30, 2022, in the Commission Chambers of City Hall. Mayor James called the meeting to order at 4:01 pm. Those in attendance were, Interim City Manager, Marc Hawkins, Commissioners Henry Strickland, Norman Davis, Sheinita Bennett and Katrena Felder.

B. Pledge of Allegiance

City Attorney, Rick Curry requested an amendment to the agenda, because there was no section for remarks on Official Actions. Mayor James opened the floor for a motion to amend the agenda. Commissioner Strickland motioned and Commissioner Felder seconded. All voted in favor, and the vote passed.

There was a Point of Privilege asked of the Mayor by Commissioner Davis. He asked Atty Rick Curry was the amendment to the agenda legally okay to do? Mr. Curry stated the Commission has the right to change the agenda, if it doesn't violate the Open Meetings Law.

#### III. CALLED MEETING:

A. Discussion of Budget for Fiscal Year 2023

Greg Smith, Director of Finance came forward and gave a presentation on the budget for fiscal year 2023.

# B. Discussion of SPLOST Intergovernmental Agreement

Attorney Rick Curry suggested that this be tabled until the July 5<sup>th</sup> Commission Meeting to give time for agreement to be signed. Commissioner Davis motioned that this be tabled until the next commission meeting, Commissioner Strickland seconded. All voted in favor and the motion carried.

#### E. Execution of Resolutions:

1. A Resolution of the City of Waycross, Georgia, To Approve the Fiscal Year 2023 (being July 1, 2022, Through June 30, 2023) Budget for the City of Waycross, and for Other Purposes.

Motion was made by Commissioner Davis to approve the Resolution, seconded by Commissioner Strickland. All voted in favor motion carried.

2. A Resolution of the City of Waycross, Georgia, To Approve an Intergovernmental Agreement with Ware County, Georgia, for the Use and Distribution of Proceeds from Special Purpose Local Option Sales Tax, and for Other Purposes.

Commissioner Davis motioned that this be tabled until the next commission meeting, being held July 5<sup>th</sup>, 2022. Commissioner Strickland seconded. All voted in favor and the motion carried.
