#### **B.** Discussion Items:

## 1. Infrastructure Update

The City Manager- met with the county, last week, and they proposed returning two parks back for use. The two parks they manage as well as the swimming pool for the next fiscal year. Currently, they want to sign an MOU about the pool operations for this summer. I told them I would get back to them when I talk to the commission. They want to have two of their commissioners and two of our commissioners sit down to discuss the MOU. At this time, and I'll put this up front that the pool is probably not cost efficient to maintain but that's one of the things they want to discuss. I'm presenting that now so we can go ahead and start the discussions on returning the two parks.

# 2. Talent Management:

## a. Approval to Include Recruitment and Retention Package to FY25 Budget

The City Manager- spoke on proposed Cola increase. As you remember, it's my goal moving this year to present anything financial to y'all at least three times prior to bidding. This is the third time as far as the cola. You should have in front of you Cola 2.5 increase. And the recommendation to do at least a 1.0 to 1.5 every year, moving forward for the next five years to catch up with inflation. That can be sustained in the budget with no issues. And with that, I would like to say, I know it's been a lot of discussions about the Cola, for our workforce. I know you all want to help the workforce, and you've done so. I'm going to go over a few notes real fast about what's been done this past year, so everybody can kind of understand how we got to the decision that we are at now. Some of this happened prior to me getting here. From 2015 to 2022, we've done either a 3% or 4% cola adjustment each year. Also, when I got here in 24, the commission decided to do the longevity increase that had been promised a few years before that. You also raised CDL raises to \$18 per hour, and that's anybody who gets a CDL. You gave birthday passes so they could either take that day off or put that into their salary. You also put it in the handbook, which we are almost done with. Also, anyone who gets degrees can get raises as well. You also get a Christmas bonus, which is \$200 every year. So, I say that because you've done a lot for the workforce as payroll, as much as you can. right now, we're to the point for another Cola adjustment. And at the same time, we're trying to make some retirement changes. Most financial experts will say not do those at the same time. So that's why it took so long for us to figure this out. We were trying to go back and forth about should we do them doing the same pay year? That made it kind of where the cola was not as high as it was in the previous years, being 3 or 4. That's why we came to 2.5. If you decide to do the Retirement and Retention package upgrade, this will be the second briefing on the retirement piece. So, I understand you need more time to consider that, and that's understandable. But on the Cola, we can maintain that. And we're going to go ahead and ask for a vote on that.

## 3. City Retreat Dates and Proposal

The City Manager proposed retreat dates of April 12th and 13th. And then the next ones will be October 11th and 12th. I want to go ahead and put these dates on the calendar so we don't run into the same issues we had trying to make them last year with holidays and people schedules so the entire workforce will know these are the dates. And like I said, the first retreat, we have a heavy focus on finances. We need a consensus and a resolution to keep it consistent moving forward.

There was a vote taken approving the dates for the Retreats. Dist-2 Sheinita Bennett-Yes, Dist-3 Katrena Felder-Yes, and Dist-5 Alvin Nelson-Yes

The City Manager spoke briefly about the letter going out to businesses concerning the proper procedures for businesses to operate and maintain compliance.

# 5. Approve Fireworks Contract for July 4<sup>th.</sup>

Marc Hawkins spoke briefly about awarding the contract to Pryotecnico for \$22,000.00.

#### 6. Wrecked Vehicle Replacement

Chief Cox spoke on the need to replace two vehicles that were wrecked earlier this year. He stated if we went with the 2023 models Dodge Durango's, which I would recommend, we already have the equipment for them. So, we've taken the equipment out of the two wrecked vehicles, and we're going into a one-year newer model vehicle. The hit as far as the budget is concerned is 327 extra dollars. Approximately a month is what will be outgoing. And I'm speaking with the finance director about it. He said that money is already in the budget. That doesn't stretch that account thin, and no amendment would be necessary. But I'm just looking for approval to go ahead and replace the 2022 models with 2023 model Dodge Durango.

There was a consensus from all three commissioners to place on tomorrow's agenda for approval.
