#### I. CALL TO ORDER:

The City Manager spoke of an emergency to have a pump replaced at the water plant, that was struck by lightning. This replacement is considered an emergency and needs a vote for purchase. The first estimate is \$10,206. But is estimated to be a little higher.

Also, he met with Ga. Power regarding the increase in rates that will happen starting July 1st. He will be meeting with Action Pack to help our senior citizens become aware of what they can potentially be qualified for and how to help in areas that they can benefit from doing. Also, there will be a meeting held at the City Auditorium with dates and times TBA to also inform our citizens on how to prepare for the increase.

He also spoke to the commissioners about contacting Patrick Simmons to schedule a town hall meeting their districts.
